### Strategies to Disseminate and Sustain Cancer Care Delivery Innovations Webinar

**Thursday, January 25th  
4-5pm ET**

**Dr. Kristie Foley and Dr. David Miller**



Cancer care delivery innovations developed and tested with grant funding may show promise for more widespread dissemination and implementation into clinical practice, but disseminating and sustaining these innovations beyond the period of funding can be quite challenging. In this webinar, two experienced NCI cancer care delivery researchers will talk about strategies for disseminating and sustaining CCDR innovations. Dr. Kristie Foley will talk about disseminating an interactive toolkit to support the implementation of smoking cessation support for patients undergoing lung cancer screening. These materials were developed during her NCORP Optimizing Lung Screening Study (OaSiS) Study (WF 20817CD). Dr. David Miller will discuss strategies for sustaining digital care delivery tools, using the example of mPATH, a digital health platform that identifies, educates and assists patients to receive colorectal cancer screening. This platform was developed and tested in a series of NCI R01 studies. This webinar may be of interest to CCDR leads, NCORP administrators, and investigators who want to understand more about how to move research tested CCDR innovations into the clinic.

  - If sites do not share providers/resources, then complete a separate Practice Interest Form for each site
  - If you're unsure, it's best to complete separate Practice Interest Forms
2. Once the Practice Interest Form is completed, the site contact will receive a Practice ID Email.
3. The site will need to upload the Practice ID Email to CTSU Regulatory Submissions. Be sure to include the PI name and their CTEP ID in the comments section.

**WF-2202- SHINE- Optimizing Psychosocial Intervention for Breast Cancer-related Sexual Morbidity: The Sexual Health and Intimacy Education Trial**



The SHINE Study is designed to learn how an internet-based program might help breast cancer survivors with sexual concerns. The primary objective is to identify which combination of four intervention components produces the greatest benefit for survivors experiencing breast cancer-related sexual morbidity with the least intervention burden. The target study population includes partnered adult women status post treatment of Stage 0-III breast cancer experiencing sexual concerns. This study can be completed remotely and participants will be asked to complete 3 online assessments throughout the study duration. ***Opening late February!!***

**WF-2302- TASTE- A Randomized, Placebo-Controlled, Pilot Study of Lactoferrin for Taste and Smell Disturbances in Cancer Patients Receiving Therapy**



The primary objective of this study is to compare the impact of 30 days of lactoferrin supplementation to placebo on self-reported chemotherapy-induced taste disturbances. We are looking for adult patients who have a pathologically confirmed diagnosis of malignancy and who are receiving platinum- or taxane-based chemotherapy. **Opening 2nd Quarter 2024!!**
