NEW AMENDMENT ACTIVATION

HYPOGRYPHE (WF-2201) Amendment 7, Protocol Version Date 05/12/2025, Release Date: 06/25/2025.

The WF NCORP Research Base study entitled *Hypofractionated Radiotherapy vs Single Fraction Radiosurgery for Brain Metastasis Patients on Immunotherapy (HYPOGRYPHE)* has been amended. The amended protocol and consent were released on June 25, 2025.

Due to recruitment occurring at such a rapid pace, we are going to pause recruitment in some strata to ensure we maintain a balanced representation of all groups throughout the recruitment phase.
